

Daycare Policies

PLEASE PRINT CLEARLY

All Dogs Must:

1. Be people & dog friendly.
2. Be healthy. If you dog has been sick in the last 2 weeks, please refrain from bringing him/her to us until your vet gives approval.
3. Be neutered or spayed if older than 7-8 months.
4. Have all vaccinations up to date, including bordatella every 6 months.
5. Puppies welcome after their first 2 sets of shots.
6. Enter and exit building on a leash.

All Owners Must:

1. Sign an application/agreement and give current copies of all medical history.
2. Bring dog in for interview to assure happy and non-aggressive disposition.
3. Make payment at time of service. If you purchase a package, there is no refund on any unused days. (initial)
4. Use your check-in card every morning that you drop off your dog. If you lose your card you will need to purchase a replacement one for \$5.
5. Pick up dog by 6:30 PM each day. Late fees are \$1 a minute.
6. Make a reservation for your dog on days he/she will be attending daycare. It's best to give at least 3- 5 days advance notice. If you make a reservation and do not show or cancel you will be charged for that day.
7. Feed your dog prior to dropping off at daycare. They will need their energy!
8. Keep your dog's vaccines up to date and bring in receipt from vet when updated.
9. If your dog is sick-having diarrhea, vomiting or coughing, or has been sprayed by a skunk please do not bring him or her to daycare.
10. We reserve the right to turn your dog away if he/she is showing any signs of illness, lice, fleas, worms, etc.

Daycare Procedures Include:

1. Fresh, filtered water will be available at all times.
2. Staff will be supervising and entertaining dogs at all times.
3. Only positive methods will be used to correct behavior.
4. While we do everything we can to invite only friendly, well-mannered, well-behaved dogs to daycare, please be aware that tiffs, dogfights and accidents can happen and dogs can be injured. If injured at daycare, we will take your dog to the vet and call to let you know. If your dog maliciously injures another dog or person, you will be responsible for all medical expenses and dog will not be allowed to return.

I have read and understand the above daycare policies. I also understand that there are no refunds given for packages purchased.

Consent for treatment & contract

In the event that my dog becomes ill or sustains an injury, I _____, authorize for the love of dog, LLC. And its representatives to obtain medical treatment in the event of an illness or accident for the following canine: _____, breed _____. I give the attending veterinarian permission to start medical treatment. In the event that the medical expenses exceed \$_____, I request that a For the love of dog, LLC. representative or the attending veterinarian to contact me before any further treatment is performed. I agree to reimburse for the love of dog, LLC. For any and all expenses incurred for the medical treatment of my dog. Payment will be made upon receipt of medical statement.

In the unlikely event that my pet passes away for any reason at daycare, I understand that he/she will be transported to my vet. If not available the pet will be transported to vet working with daycare.

I understand that the concept of doggie daycare is to allow for dogs to be socialized by interacting with people and dogs. As always, with the interaction of dogs there is a chance of injury. I assume all risk of injury to my dog while at for the love of dog daycare and spa, so long as reasonable care is taken to prevent any unnecessary injury.

I hereby waive and release For the love of dog, LLC. it's employees, officers, directors, or agents from any and all liability of any nature for any injury, death, or loss of my dog resulting from For the love of dog actions or from the action of my dog or any other dog while in the custody of, or on the grounds or surrounding area of For the love of dog, daycare and spa, not resulting from the negligence of for the love of dog, LLC.

If my dog causes injury to another dog or to a person while at for the love of dog, daycare and spa, I agree to indemnify and subrogate for the love of dog, LLC. From any action which may be brought against it, and for any defense, settlement, or judgment entered against it. I will assume all liability for the actions of my dog and agree to maintain personal liability insurance to cover me in the event of such an incident. I have been given a copy of the policies of doggie daycare and agree to abide by all policies and procedures.
